5. Health and safety.

Mark (outgoing committee) and Dave (new committee) will have separate handover. Currently Mark looks after cleaner and the annual health and safety check.

7. Role of PC in VH affairs

Felt that PC need representation on VH committee. The VHC has day to day responsibility of the running of the VH. Likely valuable for attendance at PC meetings to report activity. Formal relationship – PC is sole trustee – VHC is operational.

For events VHC obtain a temporary events licence which is cheaper than a year long events licence. Licensed all year round for public performances

9. Hall maintenance

PC In charge of maintenance and organizing schedule of works

10. Car park

Needs sign to say that liability for damage to cars is not with the VH but need PC approval for a sign.

A barrier to big events ie young farmers is lack of parking. Pete suggested using the perimeter of the village green for parking for big events only. This will need permission from PC for change of use of the green.

11. Grounds maintenance.

It was agreed using the piece of grass at the side of the hall as a community vegetable patch was a good idea. Permission to be sought from PC.

AOB:

The VH needs a new sign on the building. Not fully discussed but on the radar.

Data protection was raised – does the PC have a data protection policy – if so does this cover the VH too?

LVH needs a generic email account. Likely come with the website page. Pete and Nicole will look after this.

The office is now available as the vicar has moved out. This could potentially earn money EBS to put 'feelers out' on the village whatsapp group to see if anyone is interested in the first instance.

Painting parties: the hall needs painting so this could be done by a volunteer group. More thought to be given to this in new year.

Actions:

- EBS to email PC with the idea of occasional use of the village green for overspill parking and also a change of use of the grassy area in the curtilage of the hall to a community vegetable patch.

- Debbie and Colin to meet re finance.
